## MAJOR EVENTS COVERED

Loss or damage caused by:

- Fire + explosion
- Stranding, grounding, capsizing, sinking
- Overturning, derailment, collision
- Discharge of cargo at port of distress
- General Average
- Jettison, washing overboard
- Acts of God (Earthquake, lightning...)
- Water damage
- Loading or unloading operations
- Theft, pilferage, non-delivery
- Leakage
- Malicious damage
- Breakage or other physical loss from external cause
- Temperature variation (for reefer container)

## MAJOR EXCLUSIONS

Loss or damage caused by:

- Willful misconduct of the insured
- Inherent vice or nature of goods
- Ordinary leakage, loss in weight or volume, wear & tear
- Insufficient packing or preparation of goods
- Delay
